Taxable Perquisites: Some of the perquisites that are taxable in nature are rent-free accommodation, supply of gas, water and electricity, professional tax of employee, reimbursement of medical expense, and salary of servant employed by employee.

3. VALUATION OF PERQUISITES As a general rule, the taxable value of perquisites in the hands of the employees is its cost to the employer. However, specific rules for valuation of certain perquisites have been laid down in Rule 3 of the I.T. Rules. If employee is transferred and retain property at both the places, the taxable value of perquisites for initial period of 90 days shall be determined with reference to only one accommodation (at the option of the assessee).

Perquisites that are taxable for all the employees: Rent free accommodation; Club fee payments; Movable assets

Both of these are benefits given to the employee in kind and therefore form a part of perquisites and income tax is liable to be paid on such perquisites. While some of these perquisites are taxable like rent-free accommodations, medical expenses, free meals, club and gym facilities, supply of gas, electricity and water, some others are tax exempt. These perquisites include travel allowance, refreshments during office hours, telephone connections, health club and other recreational facilities.
